- 5) MD _____ Shooter _____ = There was a minimum 1-hour gap between Shooter and Spotter World Record Attempts.
- 6) MD _____ Shooter _____ = The Shooter and Spotter only shot or spotted once in a 5-hour period and did not shoot or spot for anyone else but their two-man team in a 24-hour period.
- 7) MD _____ Shooter _____ = There was no outside interference from any observers which could have influenced the attempt.
- 8) MD _____ Shooter _____ = None of the 10 witnesses listed here below are affiliated with or a formal/informal member of the shooters team/group.
- 9) MD _____ Shooter _____ = I was informed of, and understand the guidelines regarding a protest of record before the match.
- 10) MD _____ Shooter _____ = Submission of this form does not guarantee a record.
